3) Input of additional theoretical material in the form of links to sources on the Internet or more advanced way - multimedia method.

4) Workshops, representing different types of activities, both with native speakers and in the form of virtual collocutor.

5) Automatic checks of the results of completed assignments, since there are sometimes so many students for each teacher that he is physically unable to process the entire flow of information.

6) Students are involved in self, as well as peer-evaluation of works.

7) Online discussions are held on thematic forums. They should be considered as places where students can help each other and ask questions, express a personal attitude to a particular course, receive support and encouragement for their achievements, receive information about the course, form study groups and even organize meetings, if desired, in reality.

8) Great attention is paid to the collaboration of students, organization of the forums of questions and answers. The key point of collaboration is to improve the quality of teaching by explaining misunderstood points by students to each other. Live communication of students makes it possible to quickly eliminate the problems arising for one reason or another in the information they received. Joint viewing and discussion of lectures is encouraged, as well as the searching for answers to the tasks set in the quizzes [4, 78-80]

As a rule, the founders of large distance learning projects carry out serious research work, taking into account the information obtained in specialized forums from customer reviews. Such studies make it possible not only to assess the quality of the information services and innovations they are promoting on the market, but also to improve their training sessions at the same time.

Based on the studies that was already carried out, the following conclusions were drawn:

1) Lectures, being the basis of the theoretical course of studies, are quite competitive with webinars, provided they are enriched by the communication of students with each other, discretization and control. Also, a half hour lectures accepted as ineffective, often used on the territory of the Uzbekistan.

2) Another problem of online courses is the concessions provided by teachers to students in terms of adhering to the time regime of lectures, which are unjustified by serious reasons, due to which its effectiveness is significantly reduced. The solution in this case can only be strict adherence to the class schedule.

3) Educational institutions that offer distance learning courses in our country underestimate the importance of automating knowledge testing, as well as mutual testing of knowledge by students. Too much attention is paid on emphasis on independent learning. And cooperation between students gives very appreciable results.

4) In distance learning courses on foreign languages, much attention is paid to the communication of students with each other on thematic forums and in social networks, which influence positively on the learning outcome. We should use such techniques in Uzbek English courses.

What are the problems of English language teaching in educational institutions of Uzbekistan?

The current practice of English language teaching in the Republic of Uzbekistan suffers from a number of problems. This is another reason for the appeal of those wishing to learn a foreign language using distance learning methods. What are these problems and are distance courses completely devoid of these disadvantages?

1) Current techniques are not optimal. The time and effort spent on each student is quite large, but even in the case of high qualifications of the teacher and the division of the group into several subgroups, the learning outcomes cannot be called optimal.

2) Insufficient intensity of training students' speaking.

3) Poor basic training and too fast transition from reproductive work to productive work.

4) The negative impact of various kinds of long breaks in learning, leading to the forgetting of the material learned earlier.

5) Lack of recommendations that are sufficiently productive regarding the elimination and prevention of shortcomings in the acquisition of knowledge and speaking skills among students.

6) A lot of gaps in the work of the student assessment system.

7) Unsatisfactory selection of visual aids and low didactic effect from their use [3, 158-12]

#### **RESULT AND DISCUSSION**

Distance learning of the English language, through the use of the Internet, as a method of realizing the information rights of all participants in this process.

Information rights and obligations of students usually do not contradict each other, on the contrary, in their implementation, they complement each other. Distance learning, incorporating all the latest developments in the education system, opens up broad prospects for school education. Secondary education information systems are serious problems associated with other teaching aids such as printed materials and multimedia equipment.

Teachers of foreign languages, in particular English, as carriers of information, should not only transfer their own knowledge to students and activate each of the components of the training system, but also reproduce the content of training courses in such a way that each of them can perceive, understand and systematize the received knowledge.
